7th General Assembly of the World Scout Parliamentary Union was held from 6 November to 8 November, in Tokyo Japan.

### We, as parliamentarians gathered together in the 7th General Assembly of the World Scout Parliamentary Union:


- Recalls that in 6th General Assembly re-launched the World Scout Parliamentary Union;

- various roles that we as the parliamentarian can play in order to support young people and the Scout Movement.





### The 7th General Assembly:

- confirmed:
  - ✧ **Hon. Chung Ui-Hwa (Korea)** as the Honorary President
  - ✧ **Mr. Scott Teare (Secretary General, the World Organization of the Scout Movement)** as the Ex-Officio
- elected:
  - ✧ **Hon. Ryu Shionoya (Japan)**
  - ✧ **Hon. Ewa Thalén Finné (Sweden)**
  - ✧ **Hon. Sutham Phanthusak (Thailand)**
  - ✧ **Hon. Francisco Tinio Matugas (Philippines)**
  - ✧ **Hon. Ibrahim Gadal Tirab (Sudan)**
  - ✧ **Hon. Abdulgader Omar Mohamed Hwili (Libya)**
  - ✧ **Hon. Abdulkarim Esmali Hassan Shah (Tanzania)**

as members of the Executive Committee until the 8th General Assembly to be held in 2017.
- welcomed the **Honorable Ryu Shionoya** as the President, the **Honorable Ewa Thalén Finné** as the First Vice-President, and the **Honorable Sutham Phanthusak** as the Second Vice-President, **Hon. Abdulkarim Esmali Hassan Shah** as the Treasurer of World Scout Parliamentary Union for the next quadrennial;
- **Amended its constituions:**
  - ✧ Article 6-2 "The General Assembly meets once every three years.": changed to "**The General Assembly meets once every four years.**" This change will be applied from the 7th General Assembly.
  - ✧ Article 7-1 "The Executive Committee consists of 5 to 9 members ...": changed to "**The Executive Committee consists of 5 to 12 members ...**"
  - ✧ Article 7-2 "Members of the Executive Committee are elected for a three year mandate, renewable once." into "**Members of the Executive Committee are elected for a four year mandate, renewable once.**" In addition, added the following: "**except President and Vice President in order to make effective transition and keep continuity of the Union.**"
  - ✧ Article 8-1, second paragraph: "The Executive Committee shall elect, by ballot, the President of WORLD SCOUT PARLIAMENTARY UNION and the two Vice-Presidents from among its elected members." to "**The Executive Committee shall elect, by ballot, the President of WORLD SCOUT PARLIAMENTARY UNION and maximum of three Vice-Presidents from among its elected members.**"
  - ✧ Article 8-5 was added with "**Executive Committee may appoint Honorary Positions when necessary.**"
- Agreed that **WORLD SCOUT PARLIAMENTARY UNION** needs further expansion in terms of participating countries, therefore, gave **exceptional power to the Executive Committee to appoint vacant seat in the Executive Committee** for the next quadrennial;
- Decided that the 8th General Assembly in 2017 to be hosted in **Sweden**.
